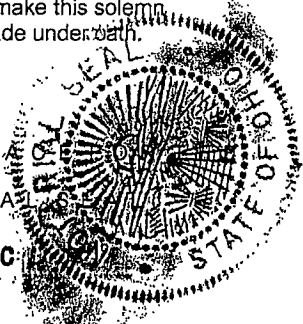

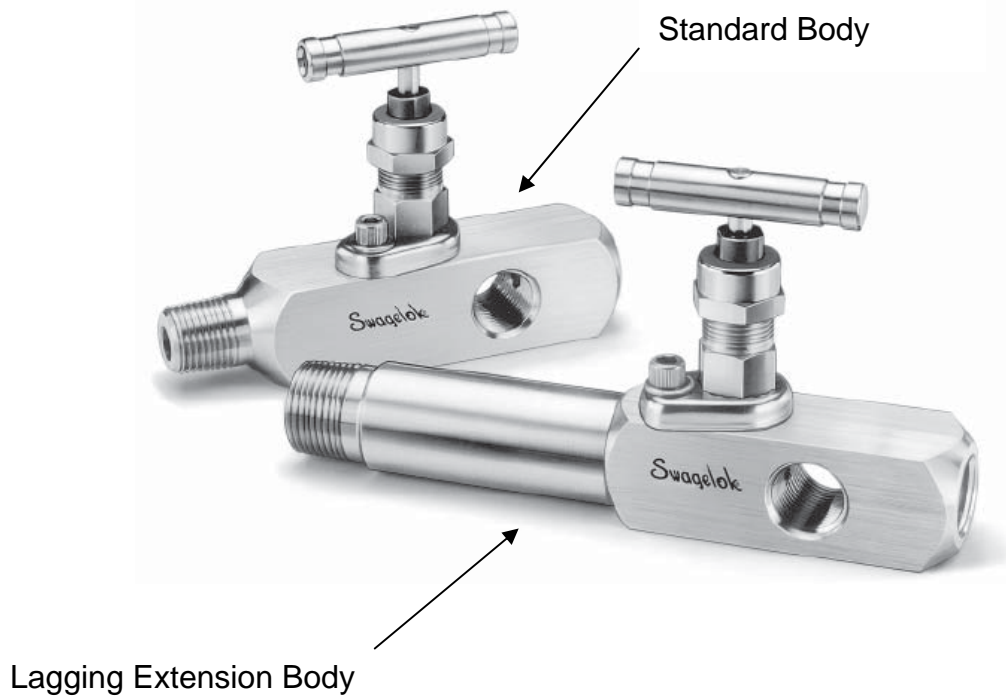
## Attachment D: Scope of CRN Registration for Swagelok 6PN Gauge Valves (Category C)
